Take Note

Making more "port pads" - at sewing bee or at home

Back in February, we had a sewing-bee to make "port pads" for cancer patients at Ellis Fischel Cancer Center. We made about 40 pads that day. The folks at the cancer center say they need up to 50 pads a month. (There are also other organizations in the community whose members make the pads, so it not all on CWSG.)

These pads provide protection from the tug and pull of seat belts, which can be quite painful if they rub against medical ports used for ease in injecting cancer treatments.

We have lots of materials to make more pads. We can certainly organize another sewing bee, and anyone can also make the pads at home.

If you are interested in sewing at home, please let Maggie Walter know, and she'll provide you with the pattern and whatever materials you need – an 8-inch by 21-inch cloth strip, Velcro, thread and CWSG tag.

Also let her know if you can provide your own materials for the pads. Soft, pliant cloth is best in patterns that would suit both men and women and children. We used flannel, chambray, corduroy, polar fleece and cotton. If you don't have cloth, we also have cloth available.

If you have cloth to donate, bring it along to the next CWSG meeting. It would be great if you could cut it into the 8x21-inch strip.

Ellis Fischel can also use soft caps and scarves so knitters and crocheters can come join in the fun as well.

Handwoven features Jenny Sennot's work, again! Jenny Sennott, a long-time member of the Columbia Weavers and Spinners' Guild and the weaving teacher at Access Arts, was again featured in Handwoven. The March/April edition's yarn lab feature was written by Sennott, who evaluated Block Island Blend Fine. It contains 37 percent hemp, 35 percent cotton and 28 percent rayon. In the article on pages 64 and 65, Sennott praises the yarn's ease of handling and suitability for use on a rigid heddle loom as well as a floor loom. There are also six photographs of the various patterns used in the sampling. Sennott's towels woven on a rigid heddle loom were featured on the cover and inside article of the November/December 2017 edition of Handwoven.

Leandra Spangler's "ROW, ROW, ROW" exhibit will be on display from June 8 to June 21 at the St. Louis Artists Guild, 12 Jackson Ave., Clayton, MO.

Spangler's work is an installation of 600+ paper rowboats. Constructed from layers of paper, each boat is unique and individually named. Tiny swivels allow independent movement from the air currents of the gallery space.

"ROW, ROW, ROW" is a work in progress. It was first exhibited as a group of 64 boats in a row of nine columns. In 2015, 247 boats were in large gallery windows. Again in 2015, nearly 400 were displayed en masse.



From the New York Times

Ethel Stein, a weaver who created countless intricate textile artworks and one particularly influential sock puppet, died March 9, 2018, on Friday in Cortlandt, N.Y. She was 100.

Her son, Carl, said the cause was complications of pneumonia.

Working largely out of the artistic limelight at her home in Croton-on-Hudson, N.Y., Ms. Stein resurrected historical weaving techniques and merged them with 20th-century Bauhaus design sensibilities.

"The result was something new and profound," Daniel Walker, former chairman of the department of textiles at the Art Institute of Chicago, said by email, "seemingly simple patterns based on geometry and shading, whose apparent simplicity had been made possible only because of the technical complexity of the weaving. Stein's artistic legacy is thus a unique one."

A more lighthearted part of her legacy came from a side business that grew out of her penchant for repurposing things that others might have discarded. She turned old socks into puppets, first for her son's nursery school, then for a growing body of fans.

She began selling them at a booth in a department store in Manhattan; a monograph published by her representative, Browngrotta Arts, says she sold 10,000. One wound up in, or on, the hands of a young puppeteer named Shari Lewis. Ms. Stein designed several puppets for Ms. Lewis, who would later in the 1950s achieve national fame with Lamb Chop, Charlie Horse and the rest of her puppet pals.

Ethel Levy was born on June 22, 1917, in New York City to Tanya Levy.

Ms. Stein was a sculptor early in her career but became increasingly interested in textiles, and in the 1970s her woven work took on a new level of complexity after she met Milton Sonday, then the curator of textiles at Cooper Hewitt, Smithsonian Design Museum. She began studying the textiles in the museum's collection, sometimes under a microscope, to see how they were made.

"Perhaps more than any other significant textile artist of the 20th century, Ethel Stein's work grew out of her study of historical textile techniques that she decoded to achieve an extraordinary freedom of expression in her own woven art works," Lucy A. Commoner, former head of conservation and senior textile conservator at Cooper Hewitt, said by email.

In 2012, Ms. Stein donated 34 of her works to the Art Institute of Chicago, which in 2014 gave her, at 96, what Mr. Walker said was her first solo exhibition. A video https://craftcouncil.org/magazine/article/ethel-stein-weavers-weaver made for that exhibition shows her not

only working a formidable loom, but also making the mathematical calculations necessary to achieve the patterns she was after, hand-dyeing the threads and more.

Mr. Walker put it simply. "She was," he said, "a weaver's weaver.

CWSG to use "consent agenda" for monthly meetings

Starting at the April 17 meeting, CWSG will begin using a "consent agenda" in an attempt to shorten the business portion of the monthly meetings.

To help folks understand how that works, here's an excerpt from "What is a Consent Agenda for a Board Meeting?" written by Jeremy Barlow for the website Board Effect. (To read the entire article, go to http://www.boardeffect.com/blog/what-is-a-consent-agenda-for-a-board-meeting/)

The consent agenda will be sent to all members via email addresses used for distributing The Tie-Up before noon on Monday preceding the Tuesday night meeting. It's up to members to read the email prior to the meeting.

A consent agenda is a meeting practice that groups routine business and reports into <u>one agenda item</u>. The consent agenda can be approved in one action, rather than filing motions on each item separately. Using a consent agenda can save anywhere from a few minutes to a half hour.

What kinds of items appear on a consent agenda?

The types of <u>items that appear on a consent agenda</u> are non-controversial items or routine items that are discussed at every meeting. They can also be items that have been previously discussed at length where there is group consensus. The following items are typically found on a consent agenda:

- The meeting minutes
- The financials
- CEO report
- · Program or committee reports
- Staff appointments
- Volunteer appointments
- Committee appointments
- Correspondence that requires no action
- Perfunctory items and/or formal approval of items that had much past discussion

There are specific rules for using the consent agenda. How the consent agenda works

The chair/president prepares an agenda package that includes all of the items on the consent agenda. The package should be distributed to members soon enough so that they have time to read through the documents prior to the meeting. **Typical steps** for using a consent agenda include:

- 1. The chair decides which items will be placed on the consent agenda. The consent agenda can appear as part of the normal meeting agenda or it can be attached separately to the meeting agenda.
- 2. The chair distributes the consent agenda and associated documents in time for board members to read and review.

- 3. At the beginning of the meeting, the board chair asks members if any of the consent agenda items should be moved to the regular discussion items.
- 4. If a member requests that an item be moved, it must be moved. Any reason is sufficient to move an item. A member can move an item to discuss the item, to query the item, or to vote against it.
- 5. Once the item has been moved, the chair may decide to take up the matter immediately or move it to a discussion item.
- 6. When there are no items to be moved or if all requested items have been moved, the chair or secretary reads out loud the remaining consent items. The chair can move to adopt the consent agenda. Hearing no objections, she can announce that the items on the consent agenda have been adopted. It's not necessary to take a vote on consent agenda items.
- 7. The secretary should include the full text of the resolutions, reports and recommendations that were adopted as part of the consent agenda.

Steps to take when a member needs clarification on a consent agenda item

Make sure that all members understand the consent agenda process to help expedite the meeting. If a member needs clarification on a consent agenda item or if she has a question, she should ask the appropriate member prior to the meeting. It's possible that other members have the same question. This should give the member being asked time to prepare an answer and distribute it to all members prior to the meeting. Consent agenda items shouldn't be pulled from the agenda just to have a question answered.

Steps to take when a member disagrees or suggests discussion

If a member disagrees with the consent agenda item or wants to move it to the regular agenda, the member would request that the item be pulled from the consent agenda. The chair would ask if the members are in favor of approving the consent agenda minus the pulled item, pause for objections and then adopt the consent agenda as noted in step #6, above.

Sample of consent agenda

- 1. Welcome/Introductions
- 2. Consent agenda
 - 1. **Board meeting minutes**
 - 2. Executive Director report
 - 3. Marketing committee report
 - 4. Approve insurance renewal
- 3. Old Business
- 4. New Business

Misuse of consent agenda

Problems in using a consent agenda occur when members approve consent agendas without first reviewing documents. The result is that consent items can be hastily approved and result in a cover-up. For example, if members are not reviewing financial items, overspending or wrong spending can occur without appropriate oversight. Remember that consent agenda items are routine and non-controversial, but even routine items should be reviewed by the entire membership. A diligent, well-rounded membership holds each other accountable.

A consent agenda is an effective and efficient tool when used appropriately. Transparency and accountability are key parts of using a consent agenda. Each member also has a responsibility to read and review consent agenda items and address any concerns prior to the meeting.
